

Dear Mr Osburn,

As organiser of the petition against sealing Aireys Street, Aireys Inlet, from the Great Ocean Rd to Sandy Gully, could you please add my name to the list of objectors.

I am on holiday in Queensland at the moment, so cannot sign the petition in person. However, I give you authority to add my name and address: Neil Liddell, [REDACTED].

I also understand that I have been sent a form to complete from the shire but fear this may be due back before I return.

I disagree with the proposal to seal our road and am very concerned about the change in the character of the street and likely increase in car speed which would result.

The unsealed road was one of the features that influenced my wife and I to choose this property and a feature we still treasure in maintaining the natural bush feel of the area.

I understand that residents in Erica Ave may prefer a sealed road as they have purchased their properties in a sealed road.

However, they did so in full knowledge that Aireys St and many of the other roads in the area are unsealed.

If others in Aireys St feel as I do, I see no reason why our street should be changed to suit the preference of residents in another street. This part of Aireys St is in fact much quieter than many other roads in the area as it is not a through road.

I would also resent having to pay a substantial cost as I do not feel that this in any way improves our amenity
