

 - 2. complete construction of new path, second half of 2016.
 - 3. removal of vegetation, second half 2016.
 - 4. construction of boundary fence, second half of 2016.
 - 5. equitation area ready for use, late 2016

- costing of extended walking path, possible funding sources Council community grant, Bendigo Bank community grant, contributions from Hall Committee, Connewarre Landcare, other yet to be identified sources.
- costing of parkland development, primarily Connewarre Landcare (grants) and Council contribution of plants & mulch, possibly over a three year period.
- costing of equipment for Equitation Park, Connewarre Horse Riding Club.
- costing for future works re decking & drainage development, future Council estimates as per master plan timelines.

Proposal for viewing mound at Connewarre Hall Precinct

The following outlines the proposal to install a viewing mound between the soccer pitch and the equine center at the Connewarre Hall precinct.

The proposed mound would go in the south west corner at a height of approximately 1m and cover an area of about 18square meters. To be seeded with Kikuyu turf which already exists on the soccer pitches, and the existing walking track to be diverted over the top of the mound.

The installation of the viewing mound would:

- Increase the viewing area of both the soccer pitches and the equine center
- Create a wind break
- Add an extra cardio workout to the existing walking track
- Increase the aesthetic of the Hall precinct
- Creates another area for children to play and use their imagination.
- Use of more native vegetation to beautify the area and create habitat
- Consultation with council means the mower that does the pitches can also mow the mound at the same time

The following pictures give an outline as to where the mound will sit and the difference in views from the current height and the proposed height.
