- Consultation with community with a lived experience of disability before works are to be completed (Accessible play space design, Spring Creek reserve, Spring Valley park, Deans marsh Reserve, Mt Moriac Reserve, Open Space master planning including Hesse St Reserve, Bellbrae and Eastern Reserve, Growing Winchelsea township planning)
- Purchase of Sandcruiser Beach Wheelchair and development of partnership with Go
 Ride a Wave to manage community bookings for the chair
- Development and adoption of Accessible and Inclusive strategy 2014-24 (January 2015)
- Progression of three Council strategies: Health and Wellbeing Plan 2013-17,
 Municipal and Emergency Management Plan, Council Plan
- Pedestrian safety on shared pathways has been given due consideration in the development of the Open Space Strategy
- Casuarina All Abilities Youth Leadership Program run across five weeks in May June with 13 young people graduating
- Re-THINK dis-ABILITY campaign launched in November 2015 by six graduates from the Enabling Women Leadership Program in 2014
- Purchase of five portable PA systems to enhance sound at community forums and events. The sound systems are located in the five Surf Coast Shire Community Houses and can be booked out for community event organisers
