Reasons for objection listed below.

- 1 . Food van has no vested interest in the community
- 2. Diminishes the character of the trading precinct.
- 3. Proposed van does no meet the specific needs, by virtue of its quality.
- 4. Unacceptable use of car parking available to registered permanent businesses.
- 5. It is proposed that future temporary food vendors have a 500 meter exclusion zone from existing businesses, for equitable consideration to existing businesses.
- 6. Detrimental to the economic well being of traders currently trading in Gilbert Street trading precinct.
- 7. Proposed site does not meet the requirements to accommodate the additional nature and volume of traffic generated.
- 8. Health issues such as waste management
- 9. Adequate water supply
- 10. Application trading hours creates nuisance from artificial light and pollution creating intrusive effects and be detrimental to neighboring property in Cliff Street, Zeally Bay Road and Boston Road.
